**Official Rules for the Snowball Secrets Promotion (the “Promotion”)**

The Promotion will take place at The Lake House at Sylvan Beach, 301 Park Ave., Sylvan Beach, NY 13157 (the “Promotion Site”) from 4:00pm – 8:00pm on July 24, 2026 (the “Promotion Times”), with hot seat drawings taking place at 4:00pm, 5:00pm, 6:00pm, 7:00pm and 8:00pm on July 24, 2026 (the “Drawing Times”). By participating, you agree to these Official Rules. Must be present to win.

**Eligibility.** Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including the YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

**How to Enter.** To enter the Promotion, eligible participants must demonstrate active slot play at the Promotion Site during the Promotion Times and be using their TS Rewards Card to be eligible to be selected to play the Snowball Secrets game for a chance to win prizes during the Promotion. Active slot play while using TS Rewards Card during the Promotion Times will constitute one (1) entry per participant per Drawing Time. Use of TS Rewards Card during active slot play is required to enter the Promotion.

**Prize(s).** One (1) winner will be randomly selected each Drawing Time from the active player database at the Promotion Site to play the Snowball Secrets game board, and select a snowball from the basket, for a chance to win Free Play prizes valued between \$25 and \$250. The basket will contain six (6) snowballs containing the following Free Play prizes: (1) \$25 Free Play prize, (1) \$50 Free Play prize, (1) \$75 Free Play prize, (1) \$100 Free Play prize, (1) \$200 Free Play prize and (1) \$250 Free Play prize. The snowball the participant picks from the basket will determine the prize value won by the participant. After the snowball is selected, it will not be returned to the basket. There will be one remaining snowball at the end of the Promotion. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone Resort Casino reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

**Winning a Prize; Odds.** Winners chosen to play the Snowball Secrets game board are randomly selected based on their location on The Lake House gaming floor. Odds of being selected to play the Snowball Secrets game board depend on how many eligible guests are actively playing on The Lake House gaming floor while using their TS Rewards Card in active slot play during the Promotion Times. The odds of each prize being awarded are \$25 Free Play (1:6), \$50 Free Play (1:6), \$75 Free Play (1:6), \$100 Free Play (1:6), \$200 Free Play (1:6) and \$250 Free Play (1:6). One (1) winner will be randomly selected from the active player database at the Promotion Site, through a computer-generated report, on July 24, 2026 at each Drawing Time to play the Snowball Secrets game board for a total of five (5) winners during the Promotion. Limit of one (1) winner per Drawing Time. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

**Claiming Prize(s).** Upon being selected, in accordance with the computer-generated report (drawing report), the individual chosen must be seated and actively playing in the location displayed on the drawing report at time of prize award. The team member will come directly to winner(s) to inform them. Once the winners have been selected, they will be given instructions as to how to play the Snowball Secrets game. Each winner will be allowed to pick a snowball from the basket that contains a slip inside the snowball indicating the value of the Free Play prize. If the individual at the winner’s location is not the same as

the person denoted on the drawing report, does not have proper identification or is not actively playing with their TS Rewards Card at the time of award, he/she will be ineligible for the prize and the prize will be forfeited to another winner. Free Play prizes are valid for 48 hours from time of award and failure to use any Free Play prize(s) within this 48-hour timeframe will result in forfeiture of these prizes. Guests standing near the designated winner and/or "Winner Location" will NOT be considered eligible to receive prizes. No compensation will be given for forfeited prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won. All prizes won will be issued upon winner's selection from the Snowball Secrets game board.

**Release.** Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members and agents, harmless from any and all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

**Voluntary Participation.** Participation is voluntary.
