Official Rules for the Spooky Crypt Kiosk Promotion (the “Promotion”)

The Promotion will take place at The Lake House at Sylvan Beach, 301 Park Ave., Sylvan Beach, NY 13157 (the “Promotion Site”) on October 2, 2026, October 3, 2026, October 9, 2026, October 10, 2026, October 16, 2026, October 17, October 23, 2026, October 24, 2026, October 30, 2026 and October 31, 2026 (each, a “Promotional Day”) from 11:00am to 7:00pm (the “Promotion Times”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law.

How to Enter. Eligible participants will earn one (1) entry into the Promotion upon earning fifty (50) slot points during the Promotion Times on a Promotional Day at the Promotion Site. Points earned towards entry are only for the Promotional Day earned and do not carry to future Promotional Days or Promotion Times. Use of TS Rewards Card during slot play is required to earn an entry. Limit one (1) entry per participant per Promotional Day. Points are only used as an entry mechanism and are not deducted from participant’s account for participation in the Promotion. Entries earned via slot play are automatically calculated. The entry must be activated by play of a virtual game at a Promotional Kiosk at the Promotion Site. Once an entry is earned, play of the virtual game is initiated when the participant swipes their TS Rewards Card at a Promotional Kiosk and selects the Spooky Crypt Kiosk Promotion tab during the Promotion Times. Play of the virtual game is required for a chance to win a prize. Promotional Kiosks are located throughout the Promotion Site. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Prize(s). There are various prizes in the Promotion including TS Rewards Points valued at \$5 (500 Points), \$10 (1,000 Points), \$25 (2,500 Points) and \$50 (5,000 Points); and Free Play prizes valued at \$5, \$10, \$25, and \$50. Not all prizes will have Free Play value. TS Rewards Point prizes are not the same as cash and the cash value assigned to the points here is for valuation purposes only. Prizes are awarded randomly at time of participation, and total number of prizes awarded depends on the number of eligible participants participating in the Promotion. All prizes awarded during the Promotion are non-negotiable and non-transferable. Eligible participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone Resort Casino reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. All eligible participants who qualify for the Promotion will receive a prize upon swiping their TS Rewards Card and playing a virtual game at a Promotional Kiosk at the Promotion Site during the Promotion Times after earning required slot points and playing a virtual game. The odds of each prize being awarded are \$5 Free Play (37:100), \$10 Free Play (1:20), \$25 Free Play (1:400), \$50 Free Play (1:4,000), 500 TS Rewards Points (19:50), 1,000 TS Rewards Points (1:20), 2,500 TS Rewards Points (1:800) and 5,000 TS Rewards Points (1:4,000).

Claiming Prize(s). All applicable prizes will be displayed on the screen of the applicable Promotional Kiosk at the completion of virtual game play. All prizes will be automatically added to the participant’s account and all Free Play and TS Rewards Point prizes must be used within 48 hours of deposit. Failure to use a Free Play and TS Rewards Point prizes within this 48-hour timeframe will result in forfeiture of the Free Play and TS Rewards Point prizes. No compensation will be given for forfeited prizes. Turning Stone will not be responsible for failure of a participant to utilize any Free Play and/or TS Rewards Point prize within the allotted 48-hour timeframe.
